Toys distributed: 15,855 toys -- 3010 books -- 4791 stocking stuffers. The number of children provided help was 2,728 and \$17,862 in donations was collected.

They also changed the life membership fee for ages 65 and over to \$200. The previous fee was \$150 for ages 61 and over.
